
Based on the second quarter statistics, Hillsborough County continues to thrive as a strong destination community. Tourism, one of the drivers of our economy, remains strong. Tampa International Airport passengers are up by over 6% compared to the previous year. Tourist Development Taxes had a record figure for the quarter at almost \$10 million, which was up by over 13%. The single family housing market stays hot with the median days to sale at 70, one of the lowest in years. In addition, employment continues to rises in manufacturing, finance and insurance, and health care services at over 3% for each. The average annual wage also rose by over 3% to \$54,392.




