
Home Sales

In October 2020, Hillsborough County had a total of **1,966** closed sales for single family homes. In October 2019, the total was **1,768** closed sales. That is a 11.2% increase in closed sales for single family homes.

In October 2020, Hillsborough County had a total of **617** closed sales for townhouses and condos. In October 2019, the total was 478 closed sales. That is a 29.1% increase in closed sales for townhouses and condos.




