
Home Sales

In March 2020, Hillsborough County had a total of **1,846** closed sales for single family homes. In March 2019, the total was 1,769 closed sales. That is a 4.4% increase in closed sales for single family homes.

In March 2020, Hillsborough County had a total of **509** closed sales for townhouses and condos. In March 2019, the total was 432 closed sales. That is a 17.8% increase in closed sales for townhouses and condos.
