
Tampa MSA consists of Hernando, Hillsborough, Pasco, and Pinellas counties.

In September 2020, Hillsborough County had a total of 1,885 closed sales for single family homes. In September 2019, the total was 1,717 closed sales. That is a 9.8% increase in closed sales for single family homes.

In September 2020, Hillsborough County had a total of **592** closed sales for townhouses and condos. In September 2019, the total was 493 closed sales. That is a 20.1% increase in closed sales for townhouses and condos.


