**WHEREAS**, Hillsborough County and the Florida Department of Community Affairs have entered into a Contractual Services Agreement for the purpose of preparation and development of Local Mitigation Strategies and pre-identification and prioritization of Hazard Mitigation Grant Program projects to become apart of the Statewide Hazard Mitigation Strategy; and

**WHEREAS**, Hillsborough County and the Cities of Tampa, Temple Terrace and Plant City have entered into Contractual Services Agreements for the purpose of preparation and development of Local Mitigation Strategies and pre-identification and prioritization of Hazard Mitigation Grant Program projects to become a part of the county-wide Hazard Mitigation Strategy; and

**WHEREAS**, Hillsborough County had the need for services in order to formulate the Countywide Mitigation Strategy, and did accept offers of the cities upon agreed upon terms and conditions; and

**WHEREAS**, the Local Mitigation Strategy Working Group compiled a Local Mitigation Strategy document that meets Contractual Agreements between the County and the State and between the Cities and the County;

**NOW THEREFORE, BE IT RESOLVED**, that the Hillsborough County Board of County Commissioners in a meeting assembled this 18<sup>th</sup> day of August 1999 adopted the Local Mitigation Strategy document, which completes the Contractual Services Agreement with the Florida Department of Community Affairs for the purpose of preparation and development of Local Mitigation Strategies and preidentification and prioritization of Hazard Mitigation Grant Projects that will become a part of the Statewide Hazard Mitigation Strategy;

**BE IT FURTHER RESOLVED**, that a copy of this resolution and the adopted Local Mitigation Strategy document be forwarded to the City of Tampa, the City of Temple Terrace, and the City of Plant City for similar action.
