SUBJECT: SUBMIT APPROVED SIGNAL WARRANT ANALYSIS PRIOR TO SIGNAL CONSTRUCTION

**PLANS** 

This bulletin requires Engineers working on Subdivisions, Site Development Projects, or County Capital Improvement Program (CIP) Projects to provide a Hillsborough County approved signal warrant analysis prior to submitting the Traffic Signal Construction Plans for review.

### **REQUIREMENTS**

Subdivisions, Site Development Projects, or County Capital Improvement Program (CIP) Projects are to provide a Hillsborough County approved signal warrant analysis prior to submitting the Traffic Signal Construction Plans for review.

The Transportation Technical Manual (TTM) Section 12.1 requires Traffic Signal Construction Plans to be submitted through Development Services Department (DSD) to the Technical Services Division (TSD). Traffic Signal Construction Plans will not be accepted for review by TSD without a Traffic Signal Warrant Analysis approved by TSD.

County Capital Improvement Program (CIP) Projects which do not have a Traffic Signal Warrant Analysis included in their Scope of Services can obtain the Traffic Signal Warrant Analysis for the intersections included in the CIP project from TSD's Traffic Engineering Section. ATraffic Signal Warrant Analysis must be included as part of the CIP project's documentation when submitting the Traffic Signal Construction Plans.
